# Studying the Zen religious music at Kaifeng "daxiangguo temple" for promotion

#### **Abstract**

This research aims to explore Zen music at the Daxiangguo Temple in Kaifeng and its promotion in modern society. The study's objectives include researching the Zen music of Daxiangguo Temple, studying the Diamond Sutra, compiling a handbook of Zen music and the Diamond Sutra, and promoting both through the handbook to the public. This study investigates the impact of Zen music on the spiritual practices of practitioners, the challenges faced during the compilation of the handbook, and effective ways to promote Zen music and the Diamond Sutra to the public. A mixed-methods approach, including interviews and surveys, has been adopted. The goal of this paper is to provide a viable path and reference for the future development of Zen music, balancing its cultural heritage value and market demand, and promoting the development and popularization of Zen music.

This research fills a gap in existing studies on Zen music and contributes to the academic field. # **Research Findings**

## 1. Knowledge of Zen music in the "daxiangguo" Temple

My experience studying Zen music at Daxiangguo Temple confirmed that the traditional plucked instruments of the Daxiangguo Temple Buddhist Orchestra include the sanxian (a three-stringed plucked instrument), pipa (a four-stringed lute), guqin (a seven-stringed zither), guzheng (a zither with more strings), and konghou (an ancient harp). The wind instruments include the sheng (a mouth-blown free reed instrument), guan (a double-reed woodwind), di (a transverse flute), xiao (a vertical bamboo flute), chui (A percussion instrument similar to a stick), and fahao (a type of large horn used in Buddhist ceremonies). The percussion instruments include bells, bianzhong (ancient chimes), drums, cymbals, yunluo (gongs arranged in a frame), and wooden fish, among others. However, as Chinese folk orchestras lack bass instruments, western instruments such as the cello and double bass have been borrowed.

The orchestra's common repertoire includes pieces such as "Pleasure in Suffering," "The Lofty Moon," "Light Pink," and "Falling Swallow." These pieces are not exclusively for Chan music; sometimes folk orchestras also perform them. Usually, the melodies are derived from traditional Chinese folk music, typically utilizing the traditional pentatonic scale. To facilitate performance, music scores are often converted into numerical notation.

Another important aspect of Chan music is Buddhist chanting, which holds significant importance in Chan music. The author lists the daily chanting repertoire of temple monks, including "Correct Conduct," "Three Precious Song," and "The Heart Sutra." These are chanted daily, divided into morning, afternoon, and evening sessions. The lyrics of these chants are composed of scriptures and mantras, which monks believe aid in their spiritual practice. The melody of these chants is kept simple, typically written in C major to avoid confusion among those unfamiliar with musical notation. The melodies often use natural major scales, primarily utilizing perfect fourths and fifths intervals, which sound very harmonious as they are used in a religious context. Although many of the lyrics are in Chinese, there are also many ancient

mantras that are direct transliterations from Indian mantras. These special mantras do not have specific meanings or direct Chinese equivalents, so phonetically similar Chinese characters are used instead. However, to ensure accurate pronunciation, monks' instruction is required.

## 2. Learn the knowledge of the Diamond Sutra at Daxiangguo Temple

The Zen Buddhist scripture, the Diamond Sutra, stands as a seminal work in this tradition. It primarily records the daily dialogues between Siddhartha Gautama, the Buddha, and his disciple Subhuti. Within these dialogues, we witness not only the profound wisdom of the Buddha but also the essential ideas embedded in the scripture. The Diamond Sutra holds a paramount position within Chinese Zen Buddhist culture.

The author meticulously correlates the 32 chapters of the scripture, a result of in-depth study and investigation within temple precincts. While this chapter primarily addresses knowledge related to Zen Buddhist music, both the musical forms and the lyrical content are deeply rooted in Zen Buddhist culture. Therefore, the study of the Diamond Sutra's content and philosophy becomes particularly crucial.

In essence, the Diamond Sutra encapsulates all the essential tenets of Zen Buddhism, advocating inner clarity and the transformative power of introspection. This path of self-discovery, akin to the exploration of the ontological self, holds the promise of profound wisdom that can benefit not only the individual but also the wider world.

#### **Discussion**

Based on field research conducted within monasteries, it has become evident that there are several challenges and issues in the dissemination of Zen Buddhist music and culture. In light of the author's extensive studies, the following areas require improvement and resolution:

The existing problems:

- 1. Lack of funds and inadequate government support.
- 2. Few activities organized within monasteries related to promoting Zen Buddhist music and culture.
- 3. Limited interaction between monastic residents and visiting tourists and audiences within monasteries, hindering the dissemination of Zen Buddhist music and culture.
- 4. The secretive nature of the monastic aspects of Zen Buddhism within monasteries, which many people are interested in but cannot find a way to understand.
- 5. Despite being a precious part of Chinese tradition, Zen Buddhist culture lacks dedicated courses in educational institutions to guide people in learning.
- 6. In today's digital age, Zen Buddhist culture lacks digital means of dissemination and relies on traditional books, which no longer keep pace with modern developments (Tan, 2005).

- 7. Lack of specialized organizations for collaborative discussions on how to promote Zen Buddhist music and culture.
- 8. The Zen Buddhist field is informationally closed, with insufficient cross-disciplinary and international exchanges to promote it among different groups in various countries.
- 9. A need for innovation in the field, to effectively disseminate it in today's era, we must integrate various art forms to keep this culture vibrant in different times.

In order to better inherit Zen music and Zen culture, the following strategies can be adopted :

- 1. Fundraising Initiatives: Establish fundraising campaigns or seek sponsorships from individuals, organizations, and even the government to secure necessary funding for the promotion and preservation of Zen Buddhist music and culture.
